### HOW TO ENTER LITHUANIA

Without Visa (visa-free regime)	With Schengen Visa C	With National Visa D
90 days during a period of 180 days in the entire Schengen area.	No longer than 90 days during a period of 180 days in the entire Schengen area.	No longer than 12 months
Note: 90 days from the first entry to Schengen for 180 days.	Note: Usually Visa C is issued at other Embassies of Schengen countries that represent Lithuania.	

## ARRIVING IN LITHUANIA WITHOUT VISA (VISA-FREE REGIME)

#### Follow these 3 steps:

Step 1: Check how many days you have left to legally stay in Lithuania;

Step 2: Apply for a temporary residence permit (TRP);

Step 3: Apply for a national VISA D while the TRP is being issued.


#### OBTAINING VISA DAT HOME VS. IN LT

#### When applying at the LT Embassy:

- Staying in LT no longer than 1 year
- Free of charge 0 €
- Ready in 15 days
- Schedule an appointment yourself (at home country embassy website)
- Inform the University about the time of appointment in advance.

#### When applying in Lithuania:

- Staying in LT no longer than 5 months
- Price 120 €
- Ready in 21 days
- Schedule an appointment at www.migracija.lt – Visits
- Inform the University about the time of appointment in advance.



## VISA D - APPLICATION

• Apply online <a href="https://visa.vrm.lt/epm">https://visa.vrm.lt/epm</a>, print it, and have a hard copy with you.

- Copy of a valid Passport
- 1 colour photo (35x45 mm)
- Bank statement (it should state that you own at least 3600€ valid for five months)
- Health insurance (insurance policy must cover at least 30,000€)
- Reference number of the mediation letter from the University (valid for one month)

Welcome to EPM

EPM is the online Visa Application Form of the Republic of Lithuania which is designed to complete and submit the Application for a Schengen or National visa to the consular services of the Republic of Lithuania.


## VISA D - APPOINTMENT

- · After entering visits at: www.migracija.lt
- · Choose your Visit type visa-application submission

Only after **request** for TRP

was submitted!

- · Choose Institution Kaunas, Chemijos st. 4B (if possible timewise, if not, choose another closest location)
- · Fill in your personal information and Reserve (don't forget to Confirm via the link in your email)



## NOTE:

- Mediation letter for Visa D issued by the University is valid for 1 month only.
- If you had Visa D before, and you need to apply for it again, please note that at least 180 days should pass since expiration of your previous Visa D.
- During Visa D validity period, it is necessary to apply for TRP and obtain a TRP card.

#### TEMPORARY RESIDENCE PERMIT

#### What documents you will need before starting:

- 1 Valid travel document Passport.
- 2 Bank statement (A document about sufficient amount of funds for living and return. Should be at least 3650€, valid for five months).
- 3 Document certifying the place of residence in Kaunas. (The rent agreement duration should be the same as the TRP validity period)
- 4 Document regarding (non)conviction (for 2 years)
- 5 Health insurance (insurance policy should cover 6000€)
- 6 Reference number of the mediation letter from the University (valid for five months)
- 7 Declaration form of place of residence in Kaunas.






#### 3 STEP - BOOK AN APPOINTMENT AT THE MIGRATION OFFICE


Note: A student must go to the Migration office on the set time with all the original documents which have to be translated into Lithuanian language.






You are aware that a foreigner holding a temporary residence permit, if he changes his identity, nationality or residence, or changes his marital status, must submit a free written notice to that effect within 7 days. *
✓ You are aware of your duty to inform about any other changes relevant to the decision on your application. *
✓ You are aware that you are liable for the submission of false data according to the laws of the Republic of Lithuania. *
You are aware that foreigner having been issued with temporary residence permit on the ground of studies, if the person has submitted a request to be accepted to a higher educational programme or PhD of another studies and science institution, not later than within 7 days he has an obligation to produce a free written declaration. You are aware that if, within 2 months from the submission of the abovenamed declaration, you don't provide evidence that you have been accepted to a higher educational programme or PhD of another studies and science institution, your temporary residence permit will be withdrawn. *





#### NOTE:

- All documents which you will present to Migration Board should be in Lithuanian language.
- If student is renting a private flat, he/ she can register the rental agreement in Centre of Registers (lt. Registrų centras) address: Ožeškienės str. 12, Kaunas.
- When a student receives a certificate from Centre of Registers, he/she can apply for TRP by him/herself. It is not necessary to go to the migration office together with the flat owner.
- The duration of rental agreement and health insurance should be the same as validity period of the TRP.

- If a rental agreement valid 1 year, but you want to apply for TRP for 2 year. Before going to Migration office you need come to International office and get an additional document, which confirm, that the University guarantee living place in the dormitory.
- If student takes the academic break, he/ she has to leave LT and TRP is terminated;
- If the student is under age of 18 years. He/she must provide a consent of their parents or other legal representatives to study in Lithuania.
- · You need to register in advance when going to pick up the TRP.

#### Visit reservation

Attention! If you wish to lodge an application to issue (renew) a residence permit you will be able to book an appointment only after you fill in the application to issue (renew) a residence permit. You may start filling the application here.

All services to foreigners are provided by pre-registration only (queueing is possible only for persons wishing to pick up produced documents or visas).

You can book visit time for a pre-visit migration service at any of the listed Migration Departments unit, regardless of your declared (planned) residence.

Only persons indicated in the registration form will receive services upon pre-registration. If the person for the visit is registered by an authorized representative, it is necessary to indicate the data of the person who wishes to receive the migration service and not the authorized representative. The contact details of the authorized representative can be specified in the Remarks field


Documents issued to foreigners - collection



## TEMPORARY RESIDENCE CERTIFICATE (TRC) FOR EU STUDENTS

- Valid travel document (Passport);
- Mediation document from the University; (<a href="https://lsmusis.lsmuni.lt">https://lsmusis.lsmuni.lt</a> Application personal details Regarding Residence Permit in the Republic of Lithuania)
- Bank statement in Lithuanian or English (at least 1500 €)
- Health insurance (e.g., the European Health Insurance Card or other Health Insurance)
- **Price** 8.60 euro.
- Declaration of residence (In the branch of the Migration Department, when withdrawing the certificate)
- The certificate is issued for the entire study period in Lithuania.
- Submit your application www.migracija.lt login

#### WHY DO YOU NEED TO APPLY FOR TRC?


If you are an EU citizen and have come to live in the Republic of Lithuania for more than 3 months in half a year, you must get a certificate confirming your right of temporary residence in the Republic of Lithuania.

Only upon receipt of a TRC, a foreign citizen is issued a personal identification number that enables one to:

- 1. Declare a place of residence in Kaunas;
- 2. Register at a Family Clinic in Lithuania;
- 3. Apply for the European Health Insurance Card at "Ligonių Kasos" (it is free of charge)
- 4. Apply to all Lithuanian institutions as an equal to a Lithuanian citizen, (e.g., apply for a driver's license)
