Migration procedures for non-EU citizens

Lithuania is a part of the Schengen area. If a foreigner has a visa-free regime, he/she may come to the Schengen area and stay here for **no longer than 90 days during a period of 180 days in the whole Schengen area**. List of countries whose citizens do not require short-stay visas to enter to the Republic of Lithuania:

According to the laws of Lithuania, all the foreigners who are non-EU citizens:

1. If they intend to stay in Lithuania for no longer than 12 months, they must obtain **a national visa D**.
2. If they intend to stay here for more than one year, they must apply for **a temporary residence permit (TRP)**.

All foreigners must declare their living place in Kaunas as they get TRP.

DECLARATION OF RESIDENCE

1. The student must declare the place of residence within 1 month of receiving the TRP card.
2. The student the declaration form must fill it in together with the owner of the apartment and sign it.
3. The completed declaration must be properly scanned (or photographed) with the student' TRP card and passport copies (student and apartment owner)
4. All these documents must be sent by e-mail to your Eldership (*Seniūnija* in lithuanian)

Before signing the rental agreement the student should ask if he/she will be able to declare that address as the place of residence.

If you need to get A NATIONAL VISA D

You must submit

In order to prepare the document inform the University about the time of the appointment for Visa D not later then 10 days.



A bank statement

A document about a sufficient amount of funds for living and return. It should be at least 4380 €



Health insurance

Health insurance must guarantee the coverage of costs and expenses of the emergency medical aid, which may occur due to the foreigner's return to the foreign state because of health issues. The insurance amount must be at least 30 000 €.

If applied at the Embassy of LT:

- A national visa can be issued for no longer than **1 year**.
- A visa fee is **120 €**.
- The decision to issue a national visa is made in **15 days**.
- To schedule an appointment at the Embassy, you should contact and register by yourself.
- Apply for Visa D only after tuition fee has been made according by the study contract.
- Register for the mediation document from the University by email: milda.mankeleviciene@lsmuni.lt

If applied in Lithuania:

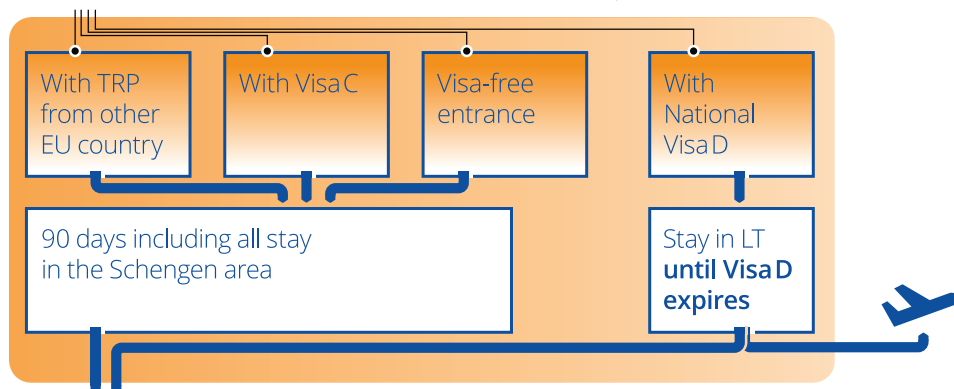
- A national visa can be issued for no longer than **5 months**.
- A visa fee is **120 €**.
- The decision to issue a national visa is made in **21 days**.

**The student can apply for a Visa D in LT, after he/
she has already submitted an application for TRP**

PAY ATTENTION:

Bank statement and mediation letter for TRP issued by the University are valid for five months.

Mediation letter for Visa D issued by the University is valid only for 1 month.

If the student is under age of 18 years, he/she must provide a consent of their parents or other legal representatives to study in Lithuania.

All documents which you will present to Migration Board should be in Lithuanian language.

A valid travel document (Passport) must meet the following requirements:

- it must be issued in the last ten years;
- it must have at least two empty pages (if you apply for national visa D);
- the date of expiry must be at least 3 months longer than the date of expiry of the requested visa or TRP.

The decision does not grant the right to stay in the Republic of Lithuania without a visa or exceed the period of a visa-free stay!

If student is renting a private flat, he/she can register the rental agreement in Centre of Registers (Lt. Registrų centras) address: Ožėškienės str. 12, Kaunas.

When a student receives a certificate from Centre of Registers, he/she can apply for TRP by him/herself. It is not necessary to go to the migration office together with the flat owner.

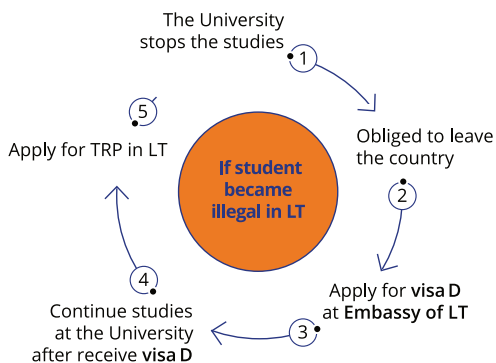
The duration of rental agreement and health insurance should be the same as validity period of the TRP.

If student takes the academic break, he/she has to leave LT and TRP is terminated.

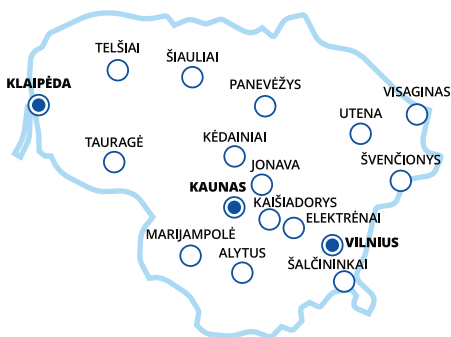
If a police certificate is made in the English language (or attached a translation of this document to English, verified by the translator's signature). Such document does not need translate to Lithuania language.

A foreigner who wants to apply for TRP must stay legal in Lithuania. It means he/she is obligated to have a valid national visa D (unless visa-free regime is applied) or a valid TRP (if you wish to renew it);

A letter regarding (non)conviction

*Necessary only for the application of
the first residence permit. These include
certificates of competent institutions of
the countries that you have lived in before
coming to Lithuania or the country that
you are currently living in for the past
2 years (except for cases, when living
in a foreign country was shorter than
6 months in a period of 12 months),
confirming that you have (or have not)
been convicted in the said countries,
which must be issued not earlier than
6 months before the application for
a residence permit, translated into
Lithuanian language with notary stamp. It
must also be legalised and (or) approved
with an Apostille.*



Health insurance

*(the insurance amount - 6000€);
The insurance must guarantee the
coverage of costs and expenses of the
emergency medical aid, which may occur
due to the foreigner's return to the foreign
state due to health issues (transportation,
including the escort of a personal health
care expert (experts)), as defined in the
Laws of Health System of the Republic
of Lithuania; and the insurance must be
valid throughout the entire period of the
foreigner's stay in the Republic
of Lithuania.*

It has to be filled by the owner of the flat.

Main things to know about TRP

the Republic of Lithuania is issued to a foreigner who is a citizen of a non-EU Member State. It is usually issued for a period of two year, though it may also be issued for a shorter period.

- When a student receives TRP, he/she has the right to work up to 20 hours per week during the period of studies, except for the summer period set by the educational institution or the institution of science and studies.
- The standard application for renewal and accompanying documents must be submitted at least 2 months before the date of expiry of the temporary residence permit, while the urgent application for a renewal and accompanying documents must be submitted at least 1 month before the date of expiry of the temporary residence permit, but not earlier than 4 months before the date of expiry.

How to apply for TRP

1 STEP

REGISTER FOR A MEDIATION LETTER FROM THE UNIVERSITY.

www.lsmu.lt -> Study at LSMU -> Registration for migration documents (non-EU)

The number of the mediation document will be sent by email.

Register online at least 5 months before TRP expiry on University website.

2 STEP

FILL AND SUBMIT TRP APPLICATION REQUEST ONLINE.

www.migracija.lt > Login

All the copies of the listed documents must be inserted in the application.

3 STEP

BOOK AN APPOINTMENT AT THE MIGRATION OFFICE.

Book an appointment for TRP in Kaunas and in other Lithuanian cities too.

A student must go to the Migration office on the set time with all the original documents which have to be translated in Lithuanian language.
