

## NATIONAL VISA D (FULL TIME STUDY PURPOSE)

An alien who is a student arriving in the Republic of Lithuania to the consecutive full-time studies at a higher education establishment operating in the Republic of Lithuania should apply for a multiple entry national visa D. At the time of submission of the first application, the applicant is required to appear in person. Decisions on the issuance or refusal to issue a visa, annulment and revocation of a visa are made by diplomatic missions and consular posts of the Republic of Lithuania. Documents can be lodged at:

### DOCUMENTS TO BE SUBMITTED BY APPLICANTS FOR NATIONAL VISA (FULL TIME STUDY PURPOSE)

1. Completed and signed National visa application form (<https://visa.vrm.lt/epm>).

2. One recent passport photo 35×45 colorful, white background.

3. A valid travel document – passport (containing at least 2 blank pages, issued within the previous 10 years, its period of validity extending at least three months after the intended date of departure from the territory of the Member States).

4. Valid health insurance covering the duration of stay (for one year). It must be valid in all participant states of the Schengen Area. The minimum amount of medical insurance coverage – EUR 30 000.

5. A confirmed Air ticket reservation.

6. Mediation letter from the University. It's mandatory register only [here](#).

**Note: The mediation number is valid for 1 month, please register once you have confirmation from the embassy or visa center.**

7. Proof of financial means to live in the Republic of Lithuania – 4400 euro (sufficient means of subsistence equal to 0.5 of the minimum monthly wage per month) and to return to the country of his or her origin or a foreign country to which the alien has the right to depart (sufficient amount of funds required to return equals to 1 minimum monthly wage)

**7.1.** Original private bank statement showing movements in the last three months, duly stamped, and signed by the bank.

**7.2.** Confirmation that you have paid a tuition fee by the study contract. It means you need to provide a confirmation from your bank that you made transfer to the university. Any additional confirmations from the university about your payments don't need to provide.

**7.3.** In case of sponsorship – Affidavit of Sponsorship from parents/relatives and their proof of financial means.

**7.4.** Highly recommend to order – **Check & Verify service**. The choice of this service speeds up the processing of visa applications, additionally proves students' motivation and willingness to study in Lithuania.

**\* Students from Israel don't need order this certificate.**

**8.** Documents providing educational background (legalized).

**9.** Consular fee.

### **PAY ATTENTION:**

#### **1. VISA AND SERVICE FEE - EUR 120\*.**

\*The visa fee may vary from country to country, as some countries may have concluded international agreements with the European Union, while others may be the subject of an implemented decision by the Council of the European Union on the increasing of the visa fee. You should inquire about the specific visa fee applicable in your country at the competent visa authority of the Republic of Lithuania.

If applying for a visa through an external service provider, a service fee is paid. Currently, Lithuania has an agreement with VF Services (UK) Ltd., the standard service fee is EUR 19.90 if there is a visa authority of the Republic of Lithuania in the country, and EUR 40 if there is not. You should inquire about the specific fee applicable in your country at the competent visa authority of the Republic of Lithuania or at VF Services (UK) Ltd.

**2. APPLICATION PROCESS AND TIME FRAME** – Applications shall be decided upon within 15 calendar days of the date of lodging of an application which is admissible. That period may be extended up to a maximum of 45 calendar days in individual cases, notably when further scrutiny of the application is needed.

#### **3. DECISION ON THE APPLICATION**

Applications shall be decided upon within 15 calendar days of the date of lodging of an application which is admissible. Applicants who have been refused a visa are notified by means of the standard form on the refusal, annulment or revocation of the visa, stating the reasons for the decision. #### **4. IMPORTANT:**

- the national visa is issued for a maximum of one year.
- the national visa is issued for a period of at least 91 days.
- if a multiple-entry national visa has been issued to you for one year, another multiple-entry national visa may be issued to you if more than 180 days have passed since your previous visa or the total validity period of all visas you have had. The total period of validity of several multiple-entry national visas must be calculated from the date of issue of the previous multiple-entry national visa, if less than 180 days have passed since the expiry of its validity.
- if you are holding a multiple-entry national visa, valid for 1 year or several multiple-entry national visas with a total validity of 1 year, and intending to apply for a temporary residence permit, in order to stay in Lithuania during the consideration of the application, you will have to submit the application in advance – 2 to 4 months before the expiry of the actual national visa.
