

Final Master's Thesis Preparation Roadmap for the Integrated Study Programme in Medicine

Year 4

Start of semester VII

1. Selection of the topic of the final thesis and the department in charge by the student.

Semester VII

2. Development of the final thesis writing plan by the student. Approval of the plan by the Supervisor. The student begins to collect references and perform literature analysis.

Start of semester VIII

3. Preparation and submission of documents by the student to the *LSMU SIS* for the approval by the *Bioethics Centre*.

Semester VIII

4. The student writes the theoretical part of the final thesis research.

End of semester VIII

5. The student submits the initial literature review to the Supervisor; the Supervisor performs the assessment and **gives and records the mark** in the *LSMU SIS* register for the course *Final Master Thesis: Research Design, scientific style and Language*.

Year 5

Semesters IX – X

6. Following the approval by the *Bioethics Centre*, the students collect, systemize and analyse the data necessary for the research are performed.
Writing of the research methodology section.

End of semester X

7. The student submits the description of the research methodology and initial research results to the Supervisor; the Supervisor performs the assessment and **gives and records the mark** in the *LSMU SIS* register for the course *Final Master Thesis: Data Collection and Systemization*.

Year 6

Semester XI

8. Completion of research data analysis, assessment of the research results. Preparation of the initial version of the final thesis.

End of semester XI

9. Submission of the initial version of the final thesis to the Supervisor; feedback from the Supervisor.

Start of semester XII

10. Review and correction of the final thesis. If shortcomings are found in the final thesis, they are corrected according to the Supervisor's comments and, by **15 February**, the thesis is submitted for the Supervisor's final review.

Semester XII

11. At the Supervisor's permission, the final thesis shall be uploaded into the *DSpace CRIS* system by **1 March**.

Semester XII

12. The Supervisor performs the text similarity and AI check on the *Identific* platform, approves the thesis title, keywords, English translation of keywords and submission of the final thesis to the reviewer in the *DSpace CRIS*.

Semester XII

13. The final thesis is submitted for the reviewer's feedback by **15 March**. The reviewer's feedback is provided by **15 April**, and the final thesis shall be corrected according to the reviewer's remarks.

Semester XII

14. The final version of the final thesis shall be uploaded to the *DSpace CRIS* system no later than one week before the scheduled date of defence. The final thesis defence shall take place by **10 May**.

Semester XII

15. The **final evaluation is recorded in the *LSMU SIS*** register within one working day after the defence.

Semester XII

16. If the student does not agree with the final evaluation of the final thesis, they have the right to appeal in accordance with the procedure laid down in the Study Regulation.
