RULES FOR ADMISSION OF STUDENTS TO THE LITHUANIAN UNIVERSITY OF HEALTH SCIENCES IN 2023

These rules regulate admission to the first, second and third (doctoral) cycle and integrated study programmes at the Lithuanian University of Health Sciences, taught in Lithuanian and foreign languages.

I. GENERAL PROVISIONS

- 1. The Rules for Admission to the First, Second and Third (Doctoral) Cycle and Integrated Study Programmes of the Lithuanian University of Health Sciences in 2023 set out the conditions and procedure for admission to the first, second and third cycle and integrated study programmes taught in Lithuanian and foreign languages in 2023.
- 2. Admission shall be held in accordance with the procedure laid down in the Rules within the deadlines set by Order of the Rector of the University, by way of competition based on the competitive score.
- 3. Admission may be carried out after the deadline for institutional admission if the applicant is applying for a non-state-funded place and if the applicant can be credited with part of the study results of the intended study programme acquired during previous studies at the University or another higher education institution, and/or the smooth integration of the applicant into the ongoing study process can be ensured. In such cases, the admission of the applicant shall be coordinated with the respective Dean of the Faculty of the University.
- 4. The data used to calculate the competitive score comes from documents showing the level of education required. The University carries out an expert assessment of the documents submitted and may contact the applicant using the contact details provided by the applicant to clarify the data.
- 5. If documents attesting education were issued by foreign institutions, documents shall be recognised in accordance with the University's procedure for the evaluation and academic recognition of foreign educational documents. Graduation documents of persons who have obtained their education in foreign institutions must be recognised in the Republic of Lithuania in accordance with the relevant procedure. To apply for recognition of education documents, applicants should contact the Centre for International Relations Studies of the Lithuanian University of Health Sciences by e-mail: ruta.antanaitiene@lsmuni.lt. The procedure of transferring (converting) grades is initiated only having assessed if the person is eligible for admission to the University, i.e. after his/ her academic qualification has been recognised (in advance) and the application for admission has been submitted. The academic qualification recognition procedure at the University is carried out within two weeks of the submission of all the necessary documents, including any additional documents requested, and the grade transfer/conversion procedure is carried out within one week. Note: Documents issued in a language other than Lithuanian must be translated and certified in accordance with the procedures provided for by law.

- 6. An applicant's invitation to study depends on the priorities set out in the application form, the competition score and the place in the competition queue for each of the study programmes specified. Once an applicant has been invited to study a particular study programme indicated in his/her application, there is no possibility to change the order of preferences in his/ her application, regardless of which other study programme the applicant might be invited to.
- 7. Applicants with the highest competition score in the competition queue and those who fall within the number of study places set by the University in the programme are considered invited to study at the University.
- 8. Additional admissions may be held for students and unclassified students for all cycles of study and for complementary studies if there are vacancies remaining.
- 9. Appeals by applicants regarding procedural violations of the Rules and technical errors in the calculation of the competition score may be submitted to the University's Admissions Commission within the deadlines approved by the Rector's Order. The Admissions Appeals Hearing Commission established by Order of the Rector hears appeals. Appeals of applicants participating in the general admission to first cycle studies are submitted and heard in accordance with the procedure and within the deadlines established by the Association of Lithuanian Higher Education Institutions for Centralised Admissions (hereinafter LAMA BPO).
- 10. Admission to first, second cycle and integrate study programmes at the student's own expense, in a foreign language, is held in accordance with the procedure set out in Section IV of the Rules.
- 11. Admission to the third cycle (doctoral studies) is held in accordance with the procedure set out in Section V of the Rules.
- 12. Admission to complementary studies is held in accordance with the procedure set out in the Annex to these Regulations.
- 13. In all cases not provided for in the Rules, decisions are taken by the University's Admissions Commission appointed by order of the Rector.
- 14. The purpose of personal data processing is to organise and carry out admission to the University's studies: to draw up admission lists (to process applicants' applications, personal identification data, data on applicants' educational documents, data on other achievements, to draw up competition queues, to carry out motivation assessment, etc.), to register and administer study agreements signed by applicants. The legal basis for the processing of personal data is the implementation of legal provisions (Article 6(1)(c) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC ("General Data Protection Regulation") (hereinafter GDPR)) and the performance of the agreement(Article 6(1)(b) of the GDPR)

II. ADMISSION TO STUDY PROGRAMMES IN LITHUANIAN

- 15. Students are admitted to first cycle and integrated studies at the University by centralised and institutional admission.
- 16. General admission is carried out in accordance with the Description of the Procedure of Centralised Admission for First Cycle and Integrates Studies of Lithuanian Higher Education Institutions. The Association of Lithuanian Higher Education Institutions for Centralised Admissions (LAMA BPO), an institution authorised by the Ministry of Education, Science and Sport of the Republic of Lithuania, arranges and holds centralised admissions. The centralised admission procedure consists of the main and additional admission. The additional admission is open to applicants who have not participated in the main admissions stage, but who meet the minimum indicators and have been assessed according to the established criteria.
- 17. Institutional admissions take place in two stages:
- 17.1. Pre-admission to LSMU (prior to the centralised admission) is available for non-state-funded places in first cycle and integrated study programmes.
- 17. 2. Additional admission to LSMU first cycle, second cycle and integrated non-state-funded study places are held in accordance with the provisions set out in Sections II and III, if the planned number of students has not been admitted through centralised and pre-admission.

18. Information on the admission procedure for first, second cycle and integral study programmes at the University is available at the Admissions Commission on weekdays from 8:00 to 12:00 and from 12:45 to 15:00. - 20. The following minimum learning outcomes are required to qualify for state-funded places in first cycle and integrated study programmes. Minimum learning outcome indicators for admission to state-funded places in university study programmes (Order No V-661 of the Minister of Education and Science of the Republic of Lithuania
- of 30 August 2017 "On the Approval of the Minimum Learning Outcome Indicators for Persons Applying for State-Funded Places in First Cycle and Integrated Studies at Higher Education Institutions as of 2020", and amendments thereto).
- 21. Applicants having acquired secondary education in Lithuania **from 2021 and** applying for state-funded first cycle and integrated study places must have passed the following state matura examinations:
- 21.1. Lithuanian language and Literature state matura examination;
- 21.2. **Mathematics** state matura examination, if the person is applying for university study programmes in all study field groups (except for study programmes in the arts study field group);
- 21.3. applicant's **elective** state matura examination;
- 21.4. **the arithmetic average** of the **best annual grades of five subjects,** which **shall be at least 7** having rounded to the nearest integer, if the person is applying to study at the university:

- 21.4.1 Lithuanian Language and Literature;
- 21.4.2. mother tongue (Belarusian, Polish, Russian or German)
- 21.4.3. a foreign language;
- 21.4.4 Mathematics:
- 21.4.5. History or Geography, or an integrated history and geography course;
- 21.4.6. Biology, Physics, Chemistry, or an integrated course in natural sciences;
- 21.4.7. a subject in the field of arts education, or a technology programme field subject, or an integrated arts and technology course, or a subject in a specialised field of education (art or engineering, or art, or music);
- 21.4.8. general physical education or the selected sport, or a programme subject in a specialised education field (sport).
- 22. Applicants having acquired secondary education in Lithuania in 2019-2020 and applying for **state-funded** first cycle and integrated study places at higher education institutions must meet the minimum learning indicators:
- 22.1. they shall have passed three state matura examinations **Lithuanian Language and Literature**, **a foreign language** (English, German or French) at B1 level at the least (or an international foreign language examination) **and Mathematics**;
- 22.2. **the arithmetic average** of the **best annual grades of five subjects**, which **shall be at least 7** having rounded to the nearest integer, if the person is applying to study at the university:
- 22.2.1. Lithuanian Language and Literature;
- 22.2.2 mother tongue (Belarusian, Polish, Russian or German);
- 22.2.3. a foreign language;
- 22.2.4. Mathematics;
- 22.2.5. History or Geography, or an integrated History and Geography course;
- 22.2.6. Biology, Physics, Chemistry or an integrated course in natural sciences;
- 22.2.7. a subject in the field of arts education, or a technology programme field subject, or an integrated arts and technology course, or a subject in a specialised field of education (art or engineering, or art, or music);
- 22.2.8. general physical education or the selected sport, or a programme subject in a specialised education field (sport).
- 23. For applicants having acquired secondary education in Lithuania in 2018:
- 23.1. they shall have passed three state matura examinations **Lithuanian Language and Literature**, **a foreign language** (English, German or French) or an international foreign language examination at B1 level at the least, **and Mathematics**, **with** a score of 25 points at the least, or the minimum learning outcomes set for 2020 (whichever is more favourable for the applicant).
- 24. For applicants having acquired secondary education in Lithuania in 2017 and 2016:
- 24.1. for applicants to state-funded study places: passed three state matura examinations **Lithuanian Language and Literature**, **a foreign language** (English, German or French) or an international foreign language examination at B1 level at the least, **and Mathematics** (with the exception of applicants to the Architecture and Music Technology programmes in the arts field study programmes);
- 25. For applicants having acquired secondary education in Lithuania in 2015:

- 25.1. for applicants to state-funded study places: passed two state matura examinations **Lithuanian Language and Literature and a foreign language** (English, German or French), or an international foreign language examination passed at B1 level at the least.
- 26. For applicants having acquired secondary education in Lithuania in **2015-2023**, applicants to **non-state-funded study places** shall be subject to Article 59(1) of the Law on Higher Education and Research of the Republic of Lithuania (passing at least one state matura examination).

27. **A document confirming** secondary **education** for those who acquired their secondary education in Lithuania **in 2014 or earlier**, also in **other cases** (for applicants who completed their secondary education in foreign institutions, under the education programmes of international organisations or foreign countries, applicants exempted from matura examinations due to illness, or those with acquired or congenital disorders).

28. Applicants to <u>non-state-funded places in Medicine and Odontology</u> study programmes are also subject to the minimum learning outcome indicators indicated in clauses 21-25 hereof.

Centralised admission

The Association of Lithuanian Higher Education Institutions for Centralised Admissions (LAMA BPO) organises and conducts centralised admissions, also forming a competitive queue of graduates of secondary education programmes. Detailed information on a centralised admission procedure, admission procedures and deadlines is available on LAMA BPO website **www.lamabpo.lt.** Centralised admission is held for: state-funded, non-state-funded study places with a study scholarship and non-state-funded study places.

29. Structure of the competition score for applicants to first cycle and integrated study programmes delivered in Lithuanian

The competition score for admission to any form of study (full-time, part-time) or type of study funding (state-funded, non-state-funded with a study scholarship, non-state-funded study places) is based on the same principles.

- 29.1. Components of the competition score:
- the grade of the first subject matura examination. In the absence of this grade, this component of the competition score is set at zero. Taking part in the competition is allowed;
- the grade of the second subject matura examination or the annual grade;
- the grade of the third subject matura examination or the annual grade. This component of the competition score consists of the grade in any subject on the matura certificate that does not duplicate another subject of the competitive score for which a state matura examination is held in the year of admission (the grade in the subject most favourable to the applicant is used). In the group of study fields of agricultural sciences, this component may also be the arithmetic average of the scores of the evaluation of theoretical and practical work of the qualification examination for the acquisition of a qualification at level IV of the Lithuanian Qualifications Framework (for those who completed vocational training programmes before 2013) or the arithmetic average of the evaluation of theoretical and practical part of the competences acquired for the acquisition of a qualification at level IV of the Lithuanian Qualifications Framework;
- the grade of the state matura examination of the fourth subject Lithuanian Language and Literature.
- 29.2. For the purposes of calculating the competition score, the grades of non-repeating subjects are used.
- 29.3. The competition score is calculated by summing up the products of the recalculated grades of matura examinations and/or annual grades and their weighting coefficients in the subjects of study, as presented in Table 2, in accordance with the procedure for the establishment of the competition queue approved by Order of the Minister of Education, Science and Sport of the Republic of Lithuania.

29.4. The competition for state-funded and non-state-funded places in the university's full-time study programmes is open only to applicants with a

competition score (excluding the additional score awarded by the university) shall be at least the following:

- For Medicine study programme 6.50;
- For Odontology study programme 6.50;
- For Veterinary Medicine study programme 5.8;
- For Pharmacy study programme 5,4.
- 29.5. The competition for state-funded places and non-state-funded places in the University's first cycle study programmes shall be open only to those persons whose competition score (excluding the additional score awarded by the University) is not lower than the minimum admission competition score set by the Minister of Education, Science and Sport in 2023, except for applicants who are exempted from matura examinations due to diseases specified in Order No V-11/18 of the Minister of Health of the Republic of Lithuania and the

Minister of Education and Science of the Republic of 8 January 2003 "On the Approval of the List of Illnesses that may be a Basis for Exempting Persons from Matura Examinations":

Admission process, procedures and deadlines

- 30. Admission takes place in two stages: centralised and institutional (before and after centralised admission) admission.
- 31. The centralised admissions process is carried out in accordance with the LAMA BPO Centralised Admissions Procedure. During the centralised admission, applicants are registered on BPIS only.
- 32. The centralised admission is organised in accordance with the procedures and deadlines set out in the Description of the Centralised Admissions Procedure.
- 33. After the competition during the main admission process:
- 33.1. the applicant may be offered one state-funded place or a state-funded place with a study scholarship, or a non-state-funded place if he/she has indicated this in his/her application;
- 33.2. once invited to study at the University, the applicant can either accept the offer or take part in the next stage;
- 33.3. if invited to study at the University, the applicant must conclude a study agreement with the University within a set period of time.
- 34. Additional admissions are limited to those groups of study fields and individual study programmes for which there are still vacancies after the main admission.
- 35. The additional admission of the centralised admission procedure is also open to persons who were not registered in the BPIS at the time of the main admission.
- 36. An applicant in the additional admission competition of the centralised admission procedure:
- 36.1. can only apply for a place that is not funded by the state if he/she has already concluded a state-funded agreement or an agreement for a non-state-funded place with a study scholarship with the University;
- 36.2. may apply for both a state-funded and a non-state-funded study place with a study scholarship or a non-state-funded study place if he/she has entered into a non-state-funded study agreement with the University or if he/she has not received or accepted an invitation to study;
- 37. If invited to study at the University, the applicant must conclude a study agreement with the University within a set period of time.

Additional points

- 38. For admission to state-funded, non-state-funded places with a study scholarship and non-state-funded places, additional points to the competition score are awarded for the applicant's achievements specified in the Description of the Procedure for Establishing the Competitive Queue in 2023 approved by Order of the Minister of Education, Science and Sport of the Republic of Lithuania.
- 39. Persons who have acquired their education in foreign institutions or under education programmes of international organisations shall be admitted to state-funded places in accordance with the procedure established by the Order No V-932 of the Minister of Education, Science and Sport of the Republic of Lithuania of 19 June 2020 "On the Approval of the Description of the Procedure of Competition for Admission of Persons Who Have Acquired Their Education at Foreign Institutions or under Educational Programmes of International Organisations for Admission to State-funded Places in Higher Educational Institutions".
- 40. Order No V-128 of the Minister of Education and Science of the Republic of Lithuania of 2 March 2017 "On the Approval of the Description of the Procedure for

Competition for Admission to State-Funded Study Places in Higher Education Institutions for Foreign Lithuanians Who Have Acquired Secondary Education in Lithuania".

- 41. Graduates of Public Institutions VšĮ LSMU gymnasium who apply for non-state-funded places in all study programmes at the University have 1 point added to their competition score.
- 42. College graduates with a degree in Pharmacy who apply for state-funded places in the Pharmacy integrated study programme have 1 point added.
- 43. College graduates with a degree in Veterinary Medicine who apply for non-state-funded places in the Veterinary Medicine integrated study programme have 1 point added.
- 44. College graduates applying for non-state-funded places in the Public Health study programme have 1 point added.
- 45. College graduates applying for non-state-funded places in the Animal Science study programme have 1 point added.
- 46. Applicants to state-funded places in Medicine, Dentistry and Veterinary Medicine study programmes who have participated in a standardised motivation assessment interview, a motivation score of 0 to 1.5 points is added to the LAMA BPO competition score.
- 47. The additional points are summed up, however, the total sum of the components cannot exceed 2.5.

Note: applicants for non-state-funded places are also subject to the provisions of clauses 38 – 40 regarding additional points.

Priority in case of equal number of points

- 48. If the applicants' scores for the main and additional criteria are identical, the person with the highest priority in descending order of priority shall have:
- 48.1. a higher sum of the grades of matura examinations multiplied by weighting factors;
- 48.2. a higher grade in the matura examination with the highest weighting coefficient;
- 48.3. a higher grade in the Lithuanian Language and Literature state matura exam;
- 48.4. whose preference has a higher priority.

Documents to be submitted

49. During the centralised admission process, persons who have accepted the invitation to study at the University shall sign study agreements remotely by logging into the LSMU Admission System *priemimas.lsmu.lt*, or their authorised persons (with a notarised power of attorney) shall come to sign a study agreement with the University within the time limits specified by LAMA BPO. A study agreement with a minor may only be concluded having arrived with one of the parents or submitted a notarised consent allowing the minor to conclude an agreement himself/ herself.

If the invitee does not sign a study agreement with the University within the specified time limits, the invitation to study at the University shall be cancelled.

- 49.1. When signing an agreement, the invitees must upload the following documents into the LSMU Admissions System:
 - a copy of a document proving the change of surname or name, if not all the documents submitted are under the same name;
 - a receipt for the registration fee paid to the LSMU bank account or copies of documents proving the right to waive the registration fee;
 - 1 documentary photo (minimum dimensions 350x350, maximum 1000x1000 pixels);
- 50. Once approved by the Council, the amount of the registration fee and the details of payment of the fee shall be published on the website https://lsmu.lt/lt/priemimas/

Institutional admission

- 51. Institutional admissions take place in two stages pre-admission (before the start of the centralised admission) and additional LSMU admission (after the end of the centralised admission). Institutional admissions are only held for non-state-funded study places. Participants in institutional admissions must meet the threshold requirements (passing at least one state matura examination and meeting the minimum competition score), except for those applying for Medicine and Odontology studies, who must also meet the minimum learning outcome indicators.
- 51.1. Only those who have completed their upper secondary education by 2023 and plan to study at a non-state-funded place can take part in pre-admission (prior to the centralised admission). Persons who will have obtained their matura certificate in the current year and intend to apply for non-state-funded places in Medicine, Odontology and Veterinary Medicine may take part in a standardised motivation assessment interview at this stage.
- 51.2. Additional LSMU admission is announced if there are vacant non-state-funded places remaining after the centralised admission. This admission stage is open to persons who did not participate in the centralised admission.

Admission process, procedures

- 52. The dates of admission approved by the Rector's Order are published on the website https://lsmu.lt/priemimas/
- 53. Applications for a permission to take part in a competition are submitted remotely by logging into the University's Admissions System at *priemimas.lsmu.lt*;
- 54. When submitting an application, the required questionnaire data must be completed, indicating the preferred study programmes in descending order of priority.
- 55. The application can contain one to three preferences in descending order of priority.
- 56. Electronic copies of the following documents must be submitted with the admission application:
- 56.1. a matura certificate and its supplement(s) or other evidence of secondary education;
- 56.2. a document proving the change of surname or name, if not all the documents submitted are under the same name.
- 57. If educational documents have been issued by a foreign institution, applications for recognition of academic qualifications are submitted online to the International Relations Study Centre before applying to study at the University. The procedure for the transfer/conversion of grades starts after the assessment of eligibility for admission to the University, the academic recognition of the qualification (obtained in advance) and the application for admission. The University carries out the academic recognition procedure within 1 month and the grade transfer/conversion procedure within 1 week. Documents issued in a language other than Lithuanian must be translated and certified in accordance with the procedure provided for by law.
- 58. Competition subjects and their weightings are indicated in Table 2 of Chapter II of these Regulations. The competition score is calculated in accordance with the Description of the Procedure for the Establishment of the Competition Queue in 2023 approved by Order of the Minister of Education, Science and Sport of the Republic of Lithuania.
- 59. Applicants to the Medicine, Odontology and Veterinary Medicine study programmes can take part in a standardised motivation assessment interview. The interview is scored on a scale of 0 to 1.5 points. The place and time of the interview are published in the LSMU Admissions System.
- 60. During the institutional admission process, persons who have accepted an invitation to study at the University sign study agreements remotely by logging in to the LSMU Admissions System

priemimas.lsmu.lt or their authorised persons (with a notarised power of attorney) come to sign a study agreement with the University within the specified deadlines.

- 61. If the invitee does not sign a study agreement with the University within the specified deadlines, the invitation to study at the University shall be cancelled.
- 62. A study agreement with a minor may only be concluded having arrived with one of the parents or submitted a notarised consent allowing the minor(s) to conclude an agreement himself/ herself.
- 63. Once approved by the Council, the amount of the registration fee and the details of payment of the fee shall be published on the University's website https://lsmu.lt/priemimas/

- 64. The dates of admission approved by the Rector's Order are published on the website https://lsmu.lt/priemimas/
- 65. Institutional admission to the first cycle *Nursing* study programme (only for those who hold a professional bachelor's degree and a general practice nursing degree) delivered in a full-time and part-time study form

is held by a separate competition.

- 65.1. The competition score is calculated using the arithmetic average of the grades in the subjects listed in the appendix/ supplement to the College Diploma. Having the same score, a preference will be given to those with the most seniority in their specialisation.
- 66. An application and the necessary documents for admission to the LSMU *Nursing* study programme (for those who have a professional bachelor's degree and a qualification of a nurse in general practice) by a separate competition shall be submitted remotely by logging in to the LSMU Admissions System *priemimas.lsmu.lt*.
- 67. The following shall be uploaded:
- 67.1. a copy of the receipt for the registration fee paid at the bank or certified copies of documents proving the right to waive the registration fee;
- 67.2. a copy of the diploma and its supplement (appendix);
- 67.3. a documentary photo (minimum dimensions 350x350, maximum 1000x1000 pixels);
- 67.4. a copy of the document proving the change of the surname or name, if not all the documents submitted are under the same surname or name;
- 68. During the institutional admission process, persons who have accepted the invitation to study at the University shall sign study agreements remotely by logging in to the LSMU Admissions System, or shall have their authorised persons (with a notarised power of attorney) arrive to sign a study agreement with the University within the deadlines set.
- 69. If the invitee fails to sign a study agreement with the University within the specified deadlines, the invitation to study at the University shall be cancelled. *Note.* Students paying the fu study price shall have until 25 October to pay for the autumn semester.

III. ADMISSION TO THE SECOND STUDY CYCLE (MASTER'S DEGREE) IN LITHUANIAN

- 74. The following persons can apply for second cycle studies:
- 74.1. those who have completed first cycle or integrated university studies and who meet the requirements set out in the Admissions Rules;
- 74.2. those who have completed higher education collegiate studies and complementary studies in the relevant field of study and meet the requirements set out in the Admissions Rules.

- 75. During the admissions process, applicants can apply for either state-funded or non-state-funded study places.
- 76. Applicants are admitted to each study programme by way of competition based on the competition score. The competition score for admission to study programmes of either form of study (full-time, part-time) or type of study funding (state-funded, non-state-funded place) is determined in accordance with the same principles.
- 77. Applicants to second cycle studies who already have a second cycle diploma and have completed more than half of their study credits in Lithuania at public expense can only apply for a non-state-funded study place.
- 78. The application form must be completed with the required information on the person and the educational qualifications obtained, and must include the credits and grades of the subjects listed in the first cycle or integrate study diploma supplement (appendix) and the credits and grades of the subjects listed in the certificate of complementary or related studies (if any).
- 79. Data on diplomas and supplements of persons having graduated from first cycle studies at the Lithuanian University of Health Sciences in 2018 2023 are transferred from the University's database to the Admissions System. The person seeking automatic transfer of data must provide consent to the University.
- 80. Persons who have completed their first cycle studies outside the University must enter the credits and grades for all subjects listed in the diploma supplement and the series, number, form code, date of issue and registration number of the diploma and appendix/ supplement, and provide electronic copies of these documents. Failure to provide this information will result in the application not being processed.
- 81. Graduation documents of persons who have received education in foreign institutions must be recognised in the Republic of Lithuania in accordance with the relevant procedure. For recognition of education documents, applicants should apply to the Centre for International Relations Studies of the Lithuanian University of Health Sciences by e-mail: ruta.antanaitiene@lsmuni.lt. The procedure of transferring (converting) grades starts only after having assessed if the person is eligible to enrol at the University, i.e. after the academic recognition of the qualification (obtained in advance) and the submission of an application for admission to the University. The academic recognition procedure at the University is carried out within two weeks of the submission of all the necessary documents, including any additional documents requested, and the grade transfer/conversion procedure within one week.

Note: Documents issued in a language other than Lithuanian must be translated and certified in accordance with the procedure provided for by laws.

Principles of calculation of the competition score

- 84. A competition score is a numerical expression of components of the competition score, calculated by taking the weighted average of the marks (grades) contained in the diploma supplement or appendix (the certificate of complementary studies, if such studies have been completed) for each applicant in each study programme.
- 84.1. If a diploma supplement (appendix) does not indicate the number of subjects in credits, the arithmetic mean of the grades of the subjects listed in the diploma supplement (appendix) is used in the calculation of the competition score.
- 84.2. The grades in the diploma supplement (appendix) in the five-point grading system are doubled. The grades in the five-point grading system are first of all converted into the ten-point marking system and then subjected to arithmetic operations.
- 84.3. If a diploma supplement (appendix) contains subjects that have been assessed as a pass/ fail, their grade are not included in the weighted average and the competition score.
- 84.4. For graduates of Lithuanian higher education institutions, grades not converted to the ten-point grading system in the diploma supplement for exchange programmes are not included in the competition score.
- 85. The motivation of applicants to second cycle study programmes is assessed by a commission (at least three members of the commission) established by orders of the Rector, separately for each study programme.
- 86. To calculate the competition score, the motivation score on a ten-point scale is multiplied by the weighting set out in the Admissions Rules. 87. An applicant who does not take part in the motivation assessment takes part in the competition but loses the motivation assessment component of the competition score.
- 88. Motivation is assessed in observance of the dates set out in the Admissions Rules and cannot be postponed.

89. All information about an applicant participating in the motivation assessment is confidential and shall not be made public.

- 94. Those who have a state-funded study agreement in the first or second stage can only apply for a non-state-funded place.
- 95. Students who have concluded an agreement for a non-state-funded study place in the first or second stage can only apply for a state-funded place.

IV. ADMISSION TO INTEGRATED, FIRST AND SECOND CYCLE SELF-FUNDED STUDIES IN ENGLISH

104. Study programmes.

- 104.1. The following study programmes are delivered in English: integrated study programmes Medicine, Odontology, Pharmacy, Veterinary Medicine; first cycle (bachelor's) study programmes Occupational Therapy, Nursing, Health Psychology; Physiotherapy, Medical and Veterinary Genetics, Oral Hygiene; second cycle (master's) study programmes Applied Public Health, Public Health Management, Lifestyle Medicine, Advanced Nursing Practice, Food Science, Animal Science, Clinical Health Psychology, Animal-Human Interaction, Laboratory Medicine Biology.
- 104.2. The competition for the University's first cycle and integrated study programmes is open to persons with sufficient English language skills (equivalent to B1 level according to the CEFR) whose level of education meets the minimum requirements for admission to higher education institutions in the Republic of Lithuania, i.e. the qualification is equivalent to the secondary education awarded in the Republic of Lithuania as evidenced by a matura certificate.
- 104.3. The competition for the University's second cycle study programmes is open to applicants with sufficient English language skills (equivalent to B1 level according to the CEFR) who have the qualifications specified in Section III, clause 82 "Competition Conditions" of these Rules. The condition of the required complementary studies in the case of a vocational bachelor's qualification obtained abroad is applicable when the qualification has been equated to a vocational bachelor's qualification following academic recognition. Admission to complementary studies in English is held in accordance with the Annex to the LSMU Admission Rules for 2023.
 - 104.4. Academic recognition of education and qualifications is carried out in accordance with the Procedure for the Assessment and Recognition of Qualifications approved by Order of the Minister of Education and Science of the Republic of Lithuania of 14 March 2016. The University reserves the right to consult with the SKVC regarding educational documents obtained in the course of educational programmes of foreign countries and international organisations. With the applicant's consent, his/her educational documents may be submitted to the SKVC for the purpose of obtaining a qualified recommendation as to the suitability of the submitted documents for studies at a higher education institution.

105. Competitive queuing and assessment of English language skills.

- 105.1. The competition score for admission to first cycle and integrated studies is based on a combination of subject knowledge and an assessment of the applicant's motivation. Subject knowledge are assessed according to one of the following alternatives:
 - based on the results of the LSMU admission examination in Chemistry (mathematics for the Health Psychology study programme) and Biology;
 - based on the results of the international universally recognised admission examinations: SAT, BMAT, MCAT, IMAT, NEET (see clause 2.5.3);
 - based on the grades of the secondary school certificate (or equivalent document) in Biology (Mathematics for the Health Psychology study programme) and Chemistry when the LSMU admission examination is not compulsory in accordance with clauses 2.5.1 and 2.5.2 of these Rules.

All the grades received another country are converted into a 10-point system according to the methodology approved by the SKVC¹ and entered into the

formula for the competition score. The applicant will then be treated as other applicants taking the entrance examination, and will be included in the general competition queue for the desired LSMU study programme.

105.2. Applicants' English language skills are assessed on the basis of the grades in their school leaving certificates, officially recognised language certificates (TOEFEL, IELTS, etc.), and the results of a subject test and a motivational interview during the admissions examination. If the applicant's ability to communicate in English is in doubt, he/she will be asked to take an English language aptitude assessment test prepared by LSMU. The minimum required score on the English language test is 50% at the least.

- 105.3. Chemistry, Biology and Mathematics test results are evaluated as a percentage (all 60 correct answers equals 100%).

Admission to complementary studies at the Lithuanian University of Health Sciences

I. General part

- 1. Admission to complementary studies is open to persons who wish to study a second cycle study programme but have a university degree in another study field or field group, or a collegiate degree in the same (or, in some cases, another) study field or field group.
- 1. Admission to complementary studies in English is open to persons who wish to study a second cycle study programme but have a university degree in another study field or field group, or in the same (or, in some cases, another) study field or fields, where their education has been recognised as equivalent to a vocational bachelor's degree.
- 3. Persons who have completed complementary studies shall be issued a certificate of completion of these studies, entitling them to enrol at the University in second cycle study programmes of study field or field group in which they had their complementary studies. The certificate shall list the modules taken, their scope in credits and the grades.
- 4.. Graduates of complementary studies are eligible to take part in the general competition for second cycle studies and to apply for state-funded or non-state-funded study places. The weighted average of the grades recorded in the supplement to the bachelor's or vocational bachelor's diploma and in the study certificate shall be taken as the basis for the calculation of their competition score
 - 5. A student has the same rights, duties and responsibilities as a student of the University, but does not have the status of a student.

II. Submission of the application, registration of documents and execution of admissions

- 1. Applications for the competition for complementary studies are accepted remotely by logging into the University's Admissions System at priemimas.lsmu.lt.
- 2. Applications for complementary studies in English can be submitted via DreamApply: https://apply.lsmuni.lt/. The documents listed in Section IV, point
- 4.1 of the Admission Rules must be submitted.
- 2. The application form must be completed with all the required questionnaire data and all the credits and grades of the subjects listed in the diploma supplement (appendix).
- 3. Copies of the following documents shall be submitted with the application:
 - 3. 1. an identity card or passport;
 - 3.2. a bachelor's or vocational bachelor's degree and its supplement (appendix);
 - 3.3. other documents evidencing education;

If the invitee does not sign a study agreement with the University within the specified time limit, the invitation to study at the University shall be cancelled.
