

# NEW / RENEWED TRP

Full-time degree students from non-EU countries are required to apply for the Temporary Residence Permit (TRP).

**1<sup>st</sup> year students** – must apply for a new TRP.

**Senior year students** - (or holders of the TRP) must apply for the renewal 4 months before the expiration of their current TRP and must renew their TRP every 2 years.

## 1. VALID TRAVEL DOCUMENT (PASSPORT)

## 2. REGISTER FOR A MEDIATION LETTER FROM THE UNIVERSITY ([click here](#))

It is usually issued within 3-7 working days. To apply for your TRP, you will need the reference number which, after it is issued, will be immediately emailed to you.

## 3. BANK STATEMENT (in Lithuanian or English) (from 1 January 2025 – at least 6228 EUR)

\* Health insurance must conform to such requirements: The insurance must guarantee the payment of emergency medical care services, as they are defined in the Law of Health Care System of the Republic of Lithuania, and expenses that could emerge due to the alien's return to the foreign country for health related reasons (transportation, including, the accompanying of health care specialist(s) and The insurance must be valid for the whole duration of the requested temporary residence permit or for at least one year.

## 5. CERTIFICATE REGARDING CONVICTION/NON-CONVICTION (only when applying for a new TRP)

\* You are required to provide a certificate from the country (or countries) where you have resided for the past 2 years before arriving to Lithuania. The document must be legalized and/or certified with an Apostille or a Secondary stamp from the Ministry of Foreign affairs of Lithuania. The certificates must be issued no earlier than 6 months prior to the submission of the TRP application.

## 6. AN UNDERTAKING (CONFIRMATION) THAT YOU WILL DECLARE YOUR PLACE OF RESIDENCE IN KAUNAS (you will click on the checkbox while filling out the application via MIGRIS).

## 7. SUBMIT YOUR APPLICATION

[www.migracija.lt](http://www.migracija.lt) → Login with email → My applications → Applications on behalf of natural persons → choose your country → I want to get a residence permit in Lithuania → I want to receive temporary residence permit → Studies → I am a student → Apply for a permit → The application to issue a temporary residence permit (upload documents and answer questions) → Choose time and date to the Migration office in Kaunas.

## 8. THE PUBLIC FEES (issue of the TRP or its renewal):

– General procedure

— **160.00** EUR (*within 2 months*)

– Urgent procedure

— **320.00** EUR (*within 1 month*)

## NOTE

■ **If a student loses his/her legal status**, the studies will be immediately suspended, and the student will be required to leave Lithuania and reapply for TRP from their home country.
