

## **INFORMATION ON THE PROCESSING OF PERSONAL DATA**

When processing your personal data, we follow the Regulation 2016/679 of the European Parliament and of the Council (EU) of 27 April 2016, on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation) and other legal acts regulating the processing of personal data.

**The scope and purpose of the processing of personal data.** We would like to inform you that your personal data will be processed for the following purposes:

- Name, surname, E-mail address and telephone number – for the purpose of registration and for the purpose of communication with you in order to notify about changes in the place, time, etc. of the consultation;
- E-mail address – with your consent, it will be possible to send personalised or general information related to education on healthy lifestyle issues;
- Name, surname and date of birth – for the purpose of your identification and in order to record the number of consultations provided to you;
- If you wish to receive a personalised service related to the individual health education and training of your individual lifestyle, and if you wish to continue the individual consultations with the healthy lifestyle educator, data about your health condition, anthropometric data, information about the identified diseases, medicines used and additional measures, existing lifestyle habits of nutrition, physical activity, mental health and bad habits may be collected.

We also inform you that statistical information will be collected, but only anonymised data will be used for statistical information.

**Legal basis for the processing of personal data.** Provision of health advice services (Regulation (EU) 2016/679 6(1)(b) and your consent (Regulation (EU) 2016/679 9(2)(a) and Regulation 2016/679 6(1)(a) (EU)).

**Transfer of personal data.** Your personal data will not be transferred to the recipients of the data, except in cases where data processors are used, who provide services to the Lithuanian University of Health Sciences and process personal data on behalf of the Lithuanian University of Health Sciences. These may include data centres, hosting and related services companies, information technology infrastructure services companies, communication services companies, etc.

Data processors shall have the right to process personal data only in accordance with the instructions of the Lithuanian University of Health Sciences and only to the extent necessary for the proper fulfilment of the contractual obligations. The Lithuanian University of Health Sciences uses only data processors who ensure that appropriate technical and organisational measures are implemented in such a way that the data processing complies with the requirements of Regulation (EU) 2016/679 and ensures the protection of your personal data.

**Term of storage of personal data.** All personal data will be stored for one current academic year and deleted centrally in September of the new academic year, no later than October 1st. If

the Customer's continuing consultations are transferred to the next academic year, personal data will be stored until the end of that academic year and deleted centrally in September of the new academic year, no later than October 1st.

**Ensuring the security of personal data.** Taking into account the level of development of technical possibilities, implementation costs and the nature, scope, context and purposes of data processing, as well as the risks of various probability and seriousness of data processing for the rights and freedoms of natural persons, we implement technical and organisational measures to ensure a level of security of your personal data that corresponds to the risk.

**Rights of data subjects.** The procedure for the implementation of your rights is set out in Regulation (EU) 2016/679, regulated by the rules for the implementation of the rights of data subjects at the Lithuanian University of Health Sciences approved by the Rector of the Lithuanian University of Health Sciences on 12 April 2021 Order No. 2021-V-0195 "on the Approval of the Rules for the Implementation of the Rights of Data Subjects at the Lithuanian University of Health Sciences".
